Course Overview

The PRO-BMT ("Professional Building Management Training") Facilities Management Plan Workshop ("WFMP") is the first of its kind available in Australia specifically tailored to train professionals working within the residential and mixed-use strata sector and Management Rights industry. The WFMP Course is an intense 3-day workshop intended to equip participants with a "Do-it-Yourself" Facilities Management Plan template and instruction on how to complete.
